Permission is hereby granted to make opening as follows:

In consideration of the issuing of a permit to open or excavate at the location above described, I hereby covenant and agree that the work shall be done in full compliance with the provisions of Chapter 232 of the Code of the City of Greensburg, Ordinance No. 1646 that is made a part of this agreement and all the Laws of the Commonwealth of Pennsylvania in relation thereto, and that I will well and truly save, defend, and keep harmless the City of Greensburg from and indemnify it against, any and all actions, suits, demands, payments, costs and charges for and by reason of the proposed opening or excavation and all damages to persons or property resulting in any manner therefrom occurring in the prosecution of the work connected therewith or from any other matter, cause of things relating thereto. That I will completely refill the opening or excavation as soon as possible so as to prevent any settling thereof and shall restore the surface to the same condition as it was before the opening or excavation, and such restoration shall be in accordance with the specifications of the Department of Highways of the Commonwealth of Pennsylvania and the City of Greensburg in effect at the time of the restoration, and the surface shall conform to the proper grade and be of the same surface and material as that part of the street or alley immediately adjoining the opening or excavation. All back fill will be done with 2B stone. During the winter months cold patch will be used. During the summer months, follow City detail. If within two (2) years after the restoration of the surface defects shall appear therein resulting from defective back filling or inferior material, I will reimburse the City of Greensburg for the cost of all necessary repairs to the permanent paving.

****The application shall be accompanied by plans showing the extent of the proposed excavation work, the dimensions and the location of the excavation work and such other information as may be prescribed by the Municipal/Consulting Engineer.***

This permit is void after thirty (30) days from the date hereof.

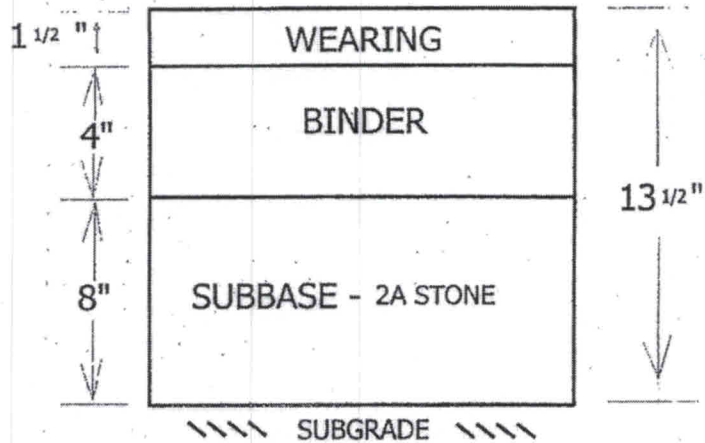
