

**CITY COUNCIL MEETING
MINUTES
Monday, December 12, 2011
7:00 p.m.**

Mayor Eisaman called the meeting to order at 7:00 p.m. City Administrator, Susan Trout, took roll call with the following members present: Councilwoman McCormick, Councilman Tridico, Councilman Peterinelli, Councilman DePasquale and Mayor Eisaman. City Solicitor, Timothy McCormick, and City Treasurer/Fiscal Director, Mary Perez, were also present.

*****COMMENTS/BUSINESS FROM THE FLOOR*****

Andy Walz, Spokesperson for State Representative Tim Krieger. Mr. Walz, "Representative Krieger is in Harrisburg and was unable to attend and he asked me to come this evening. Councilmen Peterinelli and Tridico and Mayor Eisaman have a citation at their seats that he has sponsored in honor of their service over these many years to the City of Greensburg. He wanted to express how grateful he is to have a great working relationship with each of you and you'll be missed in our business every day. So thank you." Councilman Peterinelli, "Tell him we said thank you." Mayor Eisaman, "Thank you. We appreciate it; very nice."

Cheryl Lees, representing the Pennsylvania League of Cities and Municipalities (PLCM) and PennPRIME, Workers' Compensation and Liability Insurance Carrier for the City of Greensburg. Ms. Lees, "On behalf of both organizations I would like to acknowledge and thank Mayor Eisaman for his years of service to both organizations. For the PLCM he has been a Southwest District Representative for several years, and for PennPRIME he has been on our Board of Trustees for the past eight years. For the past four years he has been on my subcommittee, and on a personal note I will sorely miss his valuable experience as both a servant of local government and his insurance background. And so, on behalf of both organizations I would like to recognize his efforts and thank him and also wish him the best on his future endeavors."

Mayor Eisaman, "Thank you, Cheryl."

Ms. Lees, "I am also here for another purpose tonight to present the City with the PennPRIME Peak Performer Award. Each year this award is presented to a select few number of Pennsylvania municipal entities. PennPRIME is unique in that it only insures small to mid-size municipal entities such as you. We're also unique in that we have a non-profit motive so all of our funds go back to you after we pay the claims. Part of the way we give funds back is through member credits, grants and the Peak Performer Award that you're going to receive tonight. The City has taken advantage of all of those in the past. The Peak Performer Award has several criteria, but one of the most important is that PennPRIME requires its members to do training for its employees on an annual basis on a focus topic. The City of Greensburg has provided that to its employees for the past six years. In addition to the PennPRIME topics they also have other topics presented by employees, and the purpose of this is to keep not only the City of Greensburg employees safe but also the residents and prevent accidents and injuries. In doing so that keeps insurance costs down and allows you to spend more money on services to the community. I am very proud that the City of Greensburg has approximately 110 employees and each and every one of them over the past six years has been represented in this training including the police who work shift work. So it's really quite an accomplishment. There are several other things that are

required to get this award and I won't go through that, but as with any award and with any success it's both the leadership and the workers that deserve the credit. I want to recognize Mayor Eisaman and also City Administrator, Sue Trout, for their continued support and commitment toward worker and resident safety. I also want to commend the Safety Committee and all of the employees of the City of Greensburg for putting their effort forward to be able to achieve this award. With this award comes a \$1,000 check upon renewal that can be used for further safety enhancements for the City. So on behalf of the PLCM and PennPRIME I would like to proudly present the Peak Performer Award to the City of Greensburg."

Ms. Lees presented the award to Mayor Eisaman and City Administrator, Sue Trout.

Ms. Trout, "Thank you very much and thank you Safety Committee."

Mayor Eisaman, "Thank you to Sue and the Safety Committee and all the employees that are part of Cheryl's efforts. It's a great cause to be safe and we even made money for it."

Chief Walter Lyons, City of Greensburg Police Department. Chief Lyons expressed his thanks and gratitude to Mayor Eisaman, Councilman Tridico and Councilman Peterinelli for their many combined years of service to the City of Greensburg. See attached.

After Chief Lyons completed his speech, Fire Chief Hutchinson replied 'times two'.

Mayor Eisaman, "Thanks, Chief."

City Administrator, Susan Trout. On behalf of the City employees and as a token of their appreciation to the Mayor and Councilmen, Ms. Trout presented them with wooden rocking chairs engraved with their years of service.

Ms. Trout conveyed her thanks and appreciation to Mayor Eisaman, Councilman Tridico and Councilman Peterinelli for the team effort they've demonstrated during their many years of service to the City of Greensburg resulting in numerous accomplishments. Mayor Eisaman, "One thing, I'd also like to thank the Fire Chief and his captains who continuously update our fire equipment and all the fire departments who also contribute to that, too. We probably have one of the more modern fleets for a community of our size and without their dedication to fundraising and purchasing the equipment we wouldn't be where we are with the department today."

Chief John E. Hutchinson, Greensburg Volunteer Fire Department. Chief Hutchinson, Ken Bacha and Tony Manley presented awards to the Mayor and the Councilmen honoring them for their years of service and dedication to the City and the Fire Department.

Mayor Eisaman, "Thank you all for those remarks and at this time I'd like to recognize and thank those individuals in attendance tonight; Andy from Representative Krieger's Office, Judge McCormick, Judge Albert, former Mayor Dan Fajt; the Mayor who started the Community Days event 20 years ago, Mayor-elect Ron Silvis, Councilman-elect Bill Eger, my wife and my in-laws, friends, employees, police officers, Fire Chief, firemen, Nancy Johnson; widow of former Councilman Wayne Johnson and the County Coroner Ken Bacha. I appreciate everyone coming tonight."

*****APPROVAL OF LAST MONTH'S COUNCIL MINUTES***** Councilman Peterinelli **MOVED** to approve the minutes from last month's Council Meeting, and Councilman DePasquale **SECONDED**. No discussion. **Unanimously all voted in favor.**

*****APPROVAL OF MONTHLY BILL LIST***** Councilman DePasquale **MOVED** to approve the bill list and pay the bills as the money becomes available, and Councilman Tridico **SECONDED**. No discussion. **Unanimously all voted in favor.**

*****REPORTS OF COUNCIL*****

Councilwoman McCormick, "The Recreation Department is taking registrations for the third session of ISI Tot Lessons and the Learn-to-Play Hockey Program. The starting date of our Boys' Winter Basketball Program had to be changed due to some scheduling conflicts with the use of the gymnasium. This program will now start on January 30th and continue until March 21st. The days and times of the program will remain the same and the length of the program will be the same. Please call the Recreation Office at 724-834-4880 with any questions. We would like to extend our appreciation and thanks to everyone who participated and came out to watch the annual Holiday Parade on November 19th. The community support for this event is very much appreciated and I especially want to thank Frank Lehman for all of his efforts. Frank, it was a wonderful day and a wonderful parade, and I only heard great comments from the community."

Mayor Eisaman, "Frank, you and your committee did a great job as always."

Councilman Tridico, reported by Councilman Peterinelli, "Last Tuesday the Street Department finished collecting leaves. The leaf collection equipment has since been removed from the large dump trucks so they are ready for snow removal. Any residents who were late in raking their leaves are directed to bag them, phone the office at 724-838-4344 and arrangements will be made to pick them up. Also, we received a fresh load of cold patch last week so any potholes that need patched will be taken care of. To comply with a request from the Department of Environmental Protection (DEP) we are conducting maintenance to the upstream portion of the Mt. Pleasant Street Flood Project. This involves removing large, downed trees from within the creek channel, placing riprap stone along the creek bed and removing built-up deposits of dirt and stone from the portions of the earth channel. The mechanics have assembled all the snow fighting equipment for the Street Department. The fleet has eight snow trucks with plows and seven salt spreaders and the snow blower has been readied also. That's the end of Tom's report."

Councilman Peterinelli, "There are several projects on tonight's agenda from the Historic and Architectural Review Board (HARB). All of these projects were given positive recommendations from the HARB. Also on tonight's agenda there's a site plan/land development for the proposed Auto Zone on 655 East Pittsburgh Street. This project has received positive recommendations from both the HARB and the Planning Commission. That concludes my report."

Councilman DePasquale, "I have all good news tonight going into Christmas. Revenues at this point at the end of November are at 104% of budget after adjusting for the temporary inter-fund transfer. That is 9% higher than revenues were at November 2010. Expenses are at 84% of budget after adjusting for the inter-fund transfer. That is 1% lower than where we were last year. And, thirdly, I'd like to report that the City received clean compliance audit reports from the Department of the Auditor General for both the Police Pension Plan and the Non-uniformed Pension Plan for both years 2009 and 2010. That concludes my report."

MAYOR'S REPORT

- a. **Code, Fire and Police Reports.** Mayor Eisaman reviewed the Code, Fire and Police Reports. Copies of these reports may be obtained at the respective offices or the City Administration Office.
- b. **Holiday Parking.** Mayor Eisaman, "In the spirit of the season parking downtown will be free after 1:00 p.m. at any meter from December 19th through December 30th to encourage the shoppers to take advantage of the great values and specialties that our downtown merchants have to offer. I would like to ask that this be posted to the City's website at www.greensburgpa.org so the public is aware of this."
- c. **2012 Swearing-in Ceremony.** Mayor Eisaman, "We will have the Swearing-in Ceremony for the new representatives coming onto City Council on Tuesday, January 3, 2012 at 10:00 a.m. here in the Council Chambers."

INTRODUCTION OF BILLS

BILL NO. 13 – AN ORDINANCE OF THE CITY OF GREENSBURG AMENDING CHAPTER 249, ENTITLED 'VEHICLES AND TRAFFIC' OF ORDINANCE NO. 1647. Ms. Trout, "Introduction of the Bill is for consideration of a petition from residents of the 200 block of Painter Avenue requesting 'Permit Parking' be removed from that portion of the street which amends §249-76; amendments to correct the schedule of streets listed under §249-70, 'Parking Prohibited at All Times' that have changed, for instance at the hospital, due to development; and to amend under §249-71, the schedule for 'Parking Prohibited Certain Hours' to allow alternative parking for residents of Pennsylvania Avenue between Third and Fourth Streets between the hours of 4:00-6:00 a.m. for street sweeper access by designating days for both sides of the street so one side is left open for parking of vehicles. In addition to amending the schedule under this section, its provisions as set forth under §249-22 for street sweeper access shall be amended to reflect the months when street sweeping is conducted which is April 1st to November 1st to free up parking during the rest of the year for the influx of residents in the downtown area." Mayor Eisaman, "Bill No. 13 is an introduction this evening. There will be no action taken."

ADOPTION OF BILLS AS ORDINANCES

BILL NO. 9 – AN ORDINANCE OF THE CITY OF GREENSBURG, COUNTY OF WESTMORELAND AND COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR CITY PURPOSES FOR THE YEAR 2012. Ms. Trout, "At this time I'm going to make a recommendation that Council vote to table this decision on the adoption of Bill No. 9 as set forth. The reason is that we are still in negotiations with both of our unions, the Teamsters and the Fraternal Order of Police (F.O.P.). We're at the end of the Teamsters agreement. We believe we may have come to an agreement on the provisions of their contract but it requires a vote. We're still working with the F.O.P., and in this process we're attempting to change our health care insurance from a Highmark product to University of Pittsburgh Medical Center (UPMC). We've been met with some challenges with that and because all of those things involve a large part of the budget and the associated Ordinance, I'm going to recommend that you table it at this time."

Mayor Eisaman, "It is also our hope that we will have these items resolved this week and hopefully have a Special Meeting next week."

Councilman DePasquale **MOVED** to **TABLE** the adoption of Bill No. 9, and Councilman Peterinelli **SECONDED**. No further discussion. Roll call vote was taken. **All voted unanimously to table the adoption of Bill No. 9.**

Mayor Eisaman, "City Solicitor, being that Bill No. 10, Bill No. 11 and Bill No. 12 are also tied to the budget, is it possible if someone chose to make a motion to table Bill Nos. 10, 11 and 12 under one motion, could we do that or do we have to do them individually?"

Solicitor McCormick, "Well, normally I would say no, but given all the speech making tonight I would suggest you can move forward in that manner, Mayor. As long as it's on record and everybody understands what they're voting on, that would be fine."

BILL NO. 10 – AN ORDINANCE AMENDING CHAPTER 151, KNOWN AS 'FEES', OF ORDINANCE NO. 1646, THE CODE OF THE CITY OF GREENSBURG, CHANGING AND/OR ADDING CERTAIN FEES AND/OR LANGUAGE FOR CERTAIN CITY SERVICES.

BILL NO. 11 – AN ORDINANCE OF THE CITY OF GREENSBURG FIXING THE NUMBER OF OFFICERS AND EMPLOYEES OF ALL DEPARTMENTS OF THE CITY OF GREENSBURG AND RATES OF COMPENSATION THEREOF FOR THE YEAR 2012.

BILL NO. 12 – AN ORDINANCE OF THE CITY OF GREENSBURG, COUNTY OF WESTMORELAND AND COMMONWEALTH OF PENNSYLVANIA, APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR SPECIFIC PURPOSES FOR THE CITY GOVERNMENT HEREINAFTER SET FORTH DURING THE YEAR 2012.

Councilman DePasquale **MOVED** to **TABLE** the adoption of Bill Nos. 10, 11 and 12, and Councilman Peterinelli **SECONDED**. No further discussion. Roll call vote was taken. **All voted unanimously to table the adoption of Bill Nos. 10, 11 and 12.**

*****ENACTMENT OF RESOLUTION*****

RESOLUTION NO. 1168 – A RESOLUTION OF MAYOR AND COUNCIL, THE GOVERNING BODY OF THE CITY OF GREENSBURG, WESTMORELAND COUNTY, PENNSYLVANIA, AUTHORIZING, EMPOWERING AND DIRECTING THE PROPER OFFICERS OF THE CITY OF GREENSBURG TO APPOINT A LIAISON BETWEEN IT AND BERKHEIMER, THE DULY APPOINTED COLLECTOR OF EARNED INCOME TAX FOR THE DISTRICT, FOR THE EXPRESS PURPOSE OF SHARING CONFIDENTIAL TAX INFORMATION WITH THE DISTRICT FOR OFFICIAL PURPOSES. Ms. Trout, "Enactment of the Resolution appoints Mary Perez, the City's Fiscal Director, as well as Tax Collector and Treasurer, as the liaison between the City and Berkheimer and the recipient of all tax information and records from Berkheimer related to the collection of taxes for the City of Greensburg. This is also in conjunction with Act 32 where we're changing our collector county-wide. It was originally and is now Keystone; we'll all be going to Berkheimer."

Councilman DePasquale **MOVED** to enact Resolution No. 1168, and Councilman Tridico **SECONDED**. No discussion. Roll call vote was taken. **All voted unanimously to enact.**

*****COUNCIL APPROVAL*****

- a. **Resignation of Member from the Civil Service Commission.** Ms. Trout, "Council approval accepts the resignation of Mayor-elect Dr. Ronald E. Silvis from the Civil Service Commission effective December 31, 2011. Dr. Silvis has served on the Commission for approximately 27 years."

Councilman Peterinelli **MOVED** to approve the resignation, and Councilman Tridico **SECONDED**. No discussion. **All voted unanimously to approve the resignation.**

Mayor Eisaman, "And before I go out on January 3rd could I send a letter to him thanking him for his years of service?"

Ms. Trout, "Absolutely."

- b. Appointment to the Civil Service Commission.** Ms. Trout, "Related to the vacancy on the Commission, Council approval appoints Dr. John Scassellati to fill the position. The Civil Service Commission is comprised of three (3) members to include a physician, an educator and a City resident at large. Dr. Scassellati will fulfill the educator obligation until July 9, 2013. We did have this offering out on our City website as we've done with other openings, and Dr. Scassellati sent around a successful letter outlining his qualifications." Mayor Eisaman, "He's been very helpful for us in the past as far as developing our website." Councilman Tridico **MOVED** to approve the appointment, and Councilman Peterinelli **SECONDED**. No further discussion. **All voted unanimously to approve.** Mayor Eisaman, "You'll get a letter out to Dr. Scassellati?" Ms. Trout, "Yes."
- c. Hiring of Seasonal Recreation Department Employees.** Ms. Trout, "The following personnel are hired as seasonal Ice Skating Coaches effective January 1, 2012: Keri Holton, Mario Siard, Brooke Leechalk, Carol Petrosky, Denise Boyle, Meredith King and Elly Hu. All of these employees are already working for us in a contracted position; they'll now be employees in the same capacity. Also, Steven Solochier is recommended to be hired as a skate guard at the rink at a rate of \$7.25 per hour. He's filling in for necessary shifts while he's on break from college." Councilwoman McCormick **MOVED** to approve the hiring of the seasonal Recreation Department employees, and Councilman DePasquale **SECONDED**. No discussion. **Mayor Eisaman abstained, and all others voted unanimously to approve.**
- d. Retirement of Full-time Employee from the Public Works Department.** Ms. Trout, "Council approval accepts a letter of resignation from Curtis Felton with an effective retirement date of January 14, 2012. Curtis currently holds the position of driver in the Street Department. We thank him for his many, many years of dedicated service and offer him our best wishes for a happy and healthy retirement." Councilman Peterinelli **MOVED** to approve the letter of resignation, and Councilman DePasquale **SECONDED**. No discussion. **All voted unanimously to approve.**
- e. Agreement between the City of Greensburg and Robert T. Regola Surveying for Public Works, Development and Building Project Consulting Services.** Ms. Trout, "Council approval renews the agreement at the same hourly rate of \$53.82 and with the same conditions of the current agreement with a 3-year term effective January 1, 2012 through December 31, 2014. An optional 1-year term shall be included for the year 2015 with negotiations to be revisited in advance for us to exercise that 1-year option." Councilman Tridico **MOVED** to approve the agreement, and Councilman Peterinelli **SECONDED**. No discussion. **All voted unanimously to approve the agreement.**
- f. Agreement between the City of Greensburg and Bill Gamble, a Police/Fire Testing Personnel Management Consultant.** Ms. Trout, "Council approval accepts the agreement with Mr. Gamble for his development of Police Civil Service Rules and Regulations for the City in the amount of \$55 per hour for technical assistance performed at his office and \$65

per hour for on-site services including travel time for a maximum cost to the City capped at \$1,100. This agreement is necessary to conform to Pennsylvania State Civil Service Law changes.”

Councilman DePasquale **MOVED** to approve the agreement, and Councilman Peterinelli **SECONDED**. No discussion. **All voted unanimously to approve the agreement.**

- g. **Slate of Projects Recommended by the Historic and Architectural Review Board (HARB) for Issuance of Certificates of Appropriateness.** Ms. Trout, “Recommendations from the HARB for approval by Council include new signs at three businesses. Located in the Historic, Gateway and Downtown Districts, Bob Gonze from Sign-a-Rama is applying for new signs for *Mark Phillips-Family Resources* at 100 North Main Street which is owned by The Westmoreland Cultural Trust. In the Gateway District, Gina Simon is the applicant for a new sign for *Gina Simon Beauty Salon* on her property at 524 East Pittsburgh Street, and in the Historic and Downtown Districts, Megan Bilik DeFazio has applied for a new sign for the *Western Pennsylvania Gas Leasing Consultants, LLC* on the property at 124 South Pennsylvania Avenue which is owned by Loughran, Mlakar & Bilik. That is your current slate.”
- Councilman Peterinelli **MOVED** to approve the slate of projects recommended for Certificates of Appropriateness, and Councilman DePasquale **SECONDED**. No discussion. **All voted unanimously to approve the slate of projects.**
- h. **Site Plan/Land Development for the Auto Zone located at 655 East Pittsburgh Street.** Ms. Trout, “This item was recommended by majority vote of the Planning Commission for Council approval; the Auto Zone.”
- Councilman Peterinelli **MOVED** to approve the site plan/land development, and Councilman DePasquale **SECONDED**. No discussion. **All voted unanimously to approve.**
- i. **Maintenance and Service Agreement between the City of Greensburg and The Verdin Company.** Ms. Trout, “Council approval renews the annual agreement for the Town Clock which includes two maintenance visits for \$575 per year. This ‘early bird’ savings rate is \$25 more than we paid last year. This is the clock in Courthouse Square that we took on under an agreement with the Rotary to provide maintenance.”
- Councilman DePasquale **MOVED** to approve the agreement, and Councilwoman McCormick **SECONDED**. No discussion. **All voted unanimously to approve.**
- j. **Emergency Purchase of Boiler for Central Fire Station.** Ms. Trout, “Council approval accepts a proposal in the amount of \$16,705 from McMahan Plumbing and Heating for the purchase and installation of a new boiler. Three bids were received from local vendors and this was the lowest bid. The old boiler had internal damage which could not be repaired and it surpassed its life expectancy. I need the vote because this exceeds the \$10,000 threshold as an emergency purchase.”
- Councilman Peterinelli **MOVED** to approve the purchase, and Councilman DePasquale **SECONDED**. No discussion. **All voted unanimously to approve the purchase.**
- k. **Emergency Roof Repair for the Mt. Odin Pro Shop.** Ms. Trout, “Council approval accepts a bid in the amount of \$12,800 from Kuzmkowski Roofing to replace the roof that is leaking from hail damage from the tornado on March 23, 2011. We had filed a claim and received a check from our insurance company in the amount of \$11,800 less the \$1,000 deductible. It is leaking and it needs repaired.”

Councilwoman McCormick **MOVED** to approve the emergency roof repair, and Councilman Peterinelli **SECONDED**. No discussion. **All voted unanimously to approve.**

- l. Consent for the Sale of Property at 540 Keystone Avenue (Tax Map No: 10-04-11-0-200) in the Amount of \$7,200 that is in the Unsold Property Repository Pursuant to Section 627 of the Real Estate Tax Sale Act.** Ms. Trout, "Written consent of each taxing district where the property is located is required prior to the sale. Consent cannot be unreasonably withheld and as long as the property is held in the Repository, it does not generate any real estate taxes. Council approval provides written consent from the City for the sale to go through."

Councilman DePasquale **MOVED** to approve the consent, and Councilwoman McCormick **SECONDED**. No discussion. **All voted unanimously to approve the consent.**
- m. Agreement between the City of Greensburg and Kane Enterprises II, Inc.** Ms. Trout, "Council approval accepts the 1-year agreement effective January 1, 2012 for the Greensburg Auto Spa to provide unlimited washing of police vehicles in the amount of \$2,940 and the complete detailing of the vehicles twice a year in the amount of \$1,960 for a total annual cost of \$4,900. This is the same price that we paid last year."

Councilman Peterinelli **MOVED** to approve the agreement, and Councilman DePasquale **SECONDED**. No discussion. **All voted unanimously to approve.**
- n. Storm Water Maintenance Agreement between the City of Greensburg and Carlo and Rosa Borriello.** Ms. Trout, "Council approval accepts the agreement in which the Borriellos as the owner/developer accept maintenance responsibilities for two detention ponds for the Department of Public Welfare building site on Sells Lane that have been constructed in accordance with plans and specifications approved by the City. This is something that Barb has been working diligently on for several years. We're hoping it comes to fruition."

Councilman Peterinelli **MOVED** to approve the agreement, and Councilman DePasquale **SECONDED**. No discussion. **All voted unanimously to approve the agreement.**
- o. Letter of Application for the IBM Challenge Grant.** Ms. Trout, "Council approval would authorize the Mayor to submit a letter applying for the funding through the grant program." Ms. Ciampini, "It's a National Challenge grant called the 'Smarter Cities Challenge Grant'. It encourages cities to apply for funding not necessarily for a solution to a problem but maybe for an enhancement and I plan on applying it to enhancements of the proposed Health Care District."

Mayor Eisaman, "And if I understand correctly its 100%?"

Ms. Ciampini, "Yes, and we need your letter of authorization for me to apply."

Councilman DePasquale **MOVED** to approve the letter of application, and Councilwoman McCormick **SECONDED**. No further discussion. **All voted unanimously to approve.**
- p. Amendment to the Agreement between the City of Greensburg and Kratzenberg and Associates, Inc., d/b/a Keystone Municipal Collections.** Ms. Trout, "Council approval accepts an amendment to the agreement that was approved just last month at the November Council meeting. It is no longer a 3-year agreement. Under Section I, entitled, 'Term', an automatic renewal for an additional year is added unless or until either party provides written notice of termination at least sixty (60) days prior to each anniversary date of the agreement. That is the only change; they didn't like our term language we had in there, so they're asking for it to be changed."

Mayor Eisaman, "And we have 60 days' notice prior to renewal?"

Ms. Trout, "Yes."

Councilman DePasquale **MOVED** to approve the amendment to the agreement, and Councilwoman McCormick **SECONDED**. No further discussion. **All voted unanimously to approve the amendment to the agreement.**

*****ADDITIONAL REMARKS*****

Councilman Peterinelli, "I've been here for 28 years. I have seen three administrators. Rege Jackson and Tom Sphon were very good guys. Then all of a sudden we got the first woman to sit in that position and she knows how to negotiate contracts, take care of the complaints and the safety end of the business, too. Mary Perez came on about 10 years ago or so. Mary is tough with money. Wally Lyons, George Seranko and all 27 police officers do a 'helluva' job, and Cindy and Amy in your office do a perfect job. Frank Lehman and Trudy Ivory do a 'helluva' job down at Lynch Field managing the swimming pool and everything else. I've known Tommy Bell almost as long as I've been on Council. Tommy is supposed to work an 8-hour shift at Mt. Odin and he spends at least 18-20 hours per day. Brian Tutich is a good Golf Pro up there, too. Les Harvey does everything you can think of. He has two guys working for him and a secretary, Kelly, and he takes care of all the problems that come to him. So I appreciate what you're doing there, Les. Bob Charley has upgraded our parking garages; they're automatic, and he takes care of all the parking meters on the streets and in the parking lots. God bless Rick Hoyle. Rick took on a 'helluva' lot of work. I think it was last year when we decided to do the street paving ourselves and he did a heck of a job. Barb Ciampini, in charge of Planning and Zoning, goes out and gets our Community Development Block Grant (CDBG) money for the City and we appreciate her and Vicky up in her office, too. And I'm sorry to see this man sitting next to me, Solicitor McCormick, go after 21 years. You've done a heck of a job for us. Mayor Eisaman, it was all said tonight up at Seton Hill. Scott Brown and Danny Fajt were good people, too. Danny Fajt was able to get the Troutman's Building for the senior citizens; I really appreciate that through Skeets Paletta, a good republican. Mayor Eisaman, you had vision just like JoAnne Boyle said tonight. You and Buddy Mertz were able to get the State Office Building up on Main Street; the Department of Health on Otterman Street; and with JoAnne Boyle you put that building on Harrison Avenue. And JoAnne Boyle is another heck of a person; she was able to change the college into a university which helped a lot. Now we have a lot of college students living in town and she brought the Lake Erie College of Osteopathic Medicine (LECOM) from Erie to Seton Hill. And, Barb takes care of all the housing for those people, and I'm just happy to say that you're doing a heck of a job yourself. I have to thank my wife. For 28 years she put up with me going to meetings, but God bless her. And if you look around town you know what Fire Chief Ed Hutchinson did in town; all the places he set up. One other guy, Pat Cribbs, known as 'Rooloo', takes care of all the buildings and the Electric Department in the City. That's about it."

Mayor Eisaman, "It's all teamwork; thank you Councilman."

Councilman DePasquale read a statement from Councilman Tridico, "When I was approached to be appointed to Council in 1991 to fill a vacancy created by the resignation of Jim Albert, I knew nothing about politics or City government. Even though I had been a public servant all my life dealing with peoples' problems I was quite apprehensive evaluating any contribution I could give to improve a better way of life for the citizens of this great City. I studied all the services and programs the City had to offer and I came to the conclusion that Greensburg has the best recreational program in the area and it has the most efficient and well-trained Fire Department that anyone could expect. The Police Department is very effective and adequate; the Street Department does an exceptional job; and the Fiscal Department is top-rated

in prudent financial management. The citizens are provided with many assets which makes Greensburg a proud City. No matter how rich is Greensburg's history its most valuable assets are the people living and working here. In that respect I've pondered many hours and tried to focus on what I could explore to form a better way of life for the citizens as my role on City Council. My past experience as a police officer for 44 years conditioned me to always be fair, but firm, and never permit personal feelings to control any decisions I had to make. I hope that now having served the people of Greensburg for these past 21 years that my legacy will reflect that I have contributed in some small way to help revitalize downtown Greensburg and made honest and fair decisions that benefitted the majority of taxpayers. I enjoyed being a member of Council. I will cherish all the good friends, both official and social that I have come to know. I want to thank my fellow colleagues and all the City employees and certainly all the citizens who supported me during my service to the City."

Mayor Eisaman, "Thank you, Tom."

Mayor Eisaman, "I just have some very brief comments. Once again I'd like to thank all of you for your efforts in making Greensburg what it is today and working together and accomplishing things. We've been very fortunate in our community. Dan Fajt, former Mayor, gave me a little bit of education. He was also very fortunate enough to work with Congressman Murtha and get us a large grant, over \$1 million, to do the Lynch Field complex, which helped us out tremendously. I appreciate that. It's been a lot of fun. I appreciate the friendships that have been created over the years, Paul, Nancy, Linda, Cindy, Harry, Jimmy, Tommy, Jeff and everybody out there. You guys all do a great job; it's been a great team and we've had a lot of fun stuff. We've had a few bumps in the road and I've had people make me think outside my black and white accounting box and it's helped out at times and moved us forward. I really appreciate all the friendships and you guys are a great team of people and I'm very proud to have been Mayor and part of this Council and to be associated with you. I will tell you that probably come January 4th I will miss the friendships and seeing you all the time; hopefully I'll see a lot of you guys more on the golf course than here at City Hall, but the one thing I will not miss is putting budgets together. I would like to thank my wife of almost 26 years for permitting me to spend the time doing this along with other non-profit groups. She's very understanding; the only day I'm not allowed to do anything is Sunday and that's usually the day we get to go shopping. I also appreciate her parents. They've been great friends and they also keep her busy when I'm busy at non-profits in the City. Thank you all very much."

In 1995 when Karl decided to run for Mayor along with Councilman Emil Peterinelli and Councilman Tom Tridico for terms on Council their campaign relied on the slogan 'Focused on Greensburg'. This team of individuals maintained their focus during their terms as community leaders. Before I discuss the many accomplishments of Karl, Tom and Emil I have to talk to you about each one as a person.

Tom, you came on Council after two successful careers in law enforcement. Serving as a Councilman you effectively had three careers in your lifetime. We wish you well and I can't thank you enough for always being there in the middle of all the strong debates and arguments and somehow bringing everybody to some human resolution. I thank you.

Karl, you are a man of unquestionable integrity and character, a well-respected, successful businessman in our community as well as in the insurance industry. I've observed many occasions of your kindness and generosity towards those less fortunate. Your compassion towards others is demonstrated through your active involvement with service agencies, a few of which are the Community Foundation of Westmoreland County, the Rotary Club, the YMCA, Westmoreland Community Action, Westmoreland Community College, Westmoreland Intermediate Unit and Special Olympics. Your business savvy has carried over into sound, fiscal management that has kept the City thriving. In handling the day-to-day operations of the City, you entrusted the professional management team you have in place to do their jobs. They in turn appreciate the freedom and trust you place in them and their abilities. Charged with running the Department of Public Safety, our police and all-volunteer fire departments are considered among the finest in the State. I consider myself one of the people with the most admiration for you, Karl. Your management abilities, guidance and insightful vision of where we should be as a City as we run the day-to-day operations have proved to be invaluable to me and to your employees. And, again, that testament is right here tonight. To have the level of mutual respect that Karl enjoys not only from me as his manager but all the City employees, the teamwork amongst the elected officials is rare and reflects only to Karl, your leadership abilities and strong character.

Greensburg is unique in that the City sits in the center of Hempfield Township also considered by many as 'Greensburg' and many times Karl is asked to perform marriages and attend ribbon-cutting ceremonies and formal functions outside Greensburg City limits and he always tries to be accommodating but never oversteps his bounds. - we supported the establishment of the new 'Five Star Walking and Bike Trail';
- organized outstanding celebrations for the City's 1999 Bicentennial event that included the State Firemen's Convention Parade, the unveiling of the new statue of Nathaniel Greene in St. Clair Park and the burying of the historical Time Capsule;
- supporting a Community Days event held for four days each year on Memorial Day weekend that has grown to be one of the best, providing free, family-oriented entertainment and fun to thousands who attend each year;
- forming a team of interested community leaders and local politicians to market the empty Troutman's Building complex which today contains lovely penthouse apartments for senior citizens, County offices, a parking facility for an adjoining church and soon a new 'green' park space on Main Street that is still undergoing construction;
- supporting the establishment of a Children's Library in the Greensburg-Hempfield Area Library ;
- successful transition into the 21st Century through the integration and upgrade of our City's technology, a lot of the time utilizing grant dollars at no cost to the City;
- support of the City's merchants in coordination of their 'Summer in the City' and 'Winter in the City' events , even participating some years in the 'dunking booth', Karl;
- we've performed various Streetscape projects in the downtown including placing utilities underground and putting in stamped pedestrian crosswalks adding to a real sense of place to the City's gateways;
- we've partnered with the Greensburg Community Development Corporation (GCDC) working together to enhance private property occupancies and façades with grant programs and assisting businesses to locate in downtown Greensburg;
- we constructed the long-awaited Mt. Pleasant Street Flood Project and soon the Northmont Flood Project;
- created over 450 new parking spaces in the downtown;

- we narrowed the truck traffic that progresses through town; that was something Jack Eisaman was very proud of;
- we implemented a parking ticket operation for fiscal accountability at two of our parking garages;
- with Wally's efforts we secured a grant to create a Regional Booking Center in the Police Department including state of the art dispatch;
- we've had sound financial management with unqualified audit reports annually for every year that I've been associated with this fine group;
- and we've partnered with the Westmoreland Museum of American Art and the Westmoreland Trust to provide the City's first ever 'Art Walk' in 2005 for a celebration of the arts;
- last and probably not least, the revitalization of our downtown through preserving our historical assets and enhancing our Cultural District with the groundbreaking for both the \$23 million Seton Hill University of the Performing Arts in 2009 and the construction of the \$12 million State Office Building in 2008 for the Department of Labor and Industry in the heart of the City right here on Main Street that provided approximately 300 jobs.

No small feat!!!!

All of these initiatives were created with teamwork in mind and with you guys working together. And, I might add you practically volunteer your time with Karl making \$4,800 a year and Tom and Emil \$3,600, which I think the majority of the time you guys donated it right back to the City through your efforts. You've all had successful lives with your families and with your businesses, and this group of people certainly wishes you well. You've been a great team, and, Karl, you have been 'Greensburg's Mayor'; not only the Mayor of Greensburg. Thank you so much for everything you've done. 'Hats off' to Karl, Tom and Emil for a job well done!
