AN ORDINANCE
OF THE CITY OF GREENSBURG, COUNTY OF WESTMORELAND
AND COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX
RATE FOR CITY PURPOSES FOR THE YEAR 2011.

BE IT ORDAINED AND ENACTED by the City of Greensburg, in Council assembled
as follows:

Section 1. Pursuant to the authority contained in the Home Rule Charter, Article XIV,
Section 1408, the taxes hereafter set forth are hereby levied on all persons and property within said
City subject to taxation for City purposes, for the year 2011:

- a. For general revenue purposes, the sum of 18.30 Mills, of assessed valuation of
all real estate; and
- b. For debt purposes, the sum of 6.75 Mills, of assessed valuation of all real estate,
making a total of Twenty-five and five hundredths (25.05) Mills, or the sum of
Two Dollars and Five Hundred Five Thousandths (2.505) Cents on One
Hundred Dollars (\$100) of assessed valuation of all real estate.

Section 2. All ordinances or parts of ordinances conflicting with the provisions of this
ordinance are hereby repealed.

Section 3. This ordinance shall take effect on the 1st day of January 2011.

AN ORDINANCE AMENDING CHAPTER 151, KNOWN AS "FEES", OF ORDINANCE NO. 1646. CHANGING, DELETING AND/OR ADDING CERTAIN FEES AND/OR LANGUAGE FOR CITY SERVICES IN VARIOUS DEPARTMENTS.

BE IT ORDAINED, by the Council of the City of Greensburg to amend Chapter 151 of Ordinance No. 1646 as follows:

Section 1. Article I, Police, of Chapter 151 is amended as follows:

ADD under §151-1, entitled 'Documents' the following fee increase:

Type	Fee
Police employment application	(DELETE) \$35 (ADD) \$50.

Section 2. Article III, *Recreation*, of Chapter 151 is amended establishing a new section entitled, "Events" and fee schedule:

ADD the following new section and Title:

§151-5.3 Events.

ADD the following events and fees as follows:

Section 3. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed.
