AN ORDINANCE
TO AMEND CHAPTER 151, KNOWN AS "FEES", OF ORDINANCE NO. 1646.
CHANGING, DELETING AND/OR ADDING CERTAIN FEES AND/OR
LANGUAGE FOR CITY SERVICES IN VARIOUS DEPARTMENTS.

BE IT ORDAINED, by the Council of the City of Greensburg to amend Chapter 151 of Ordinance No. 1646 as follows:

Section 1. Article I: Police, of Chapter 151 is amended to include the following fees and/or fee rate changes, deletions and/or language:

§151-1 Documents and Services:

Fingerprinting	\$10 (DELETE) \$15(ADD)
Alarm monitor fee (DELETE)	\$180 per year (DELETE)
Dispatch services for municipalities	\$7,000 (DELETE) per agreement (ADD)

Section 2. Article III: Recreation, of Chapter 151 is amended to include the following fees and/or fee rate changes, deletions and/or language.


Section 4. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed.
