AN ORDINANCE

OF THE CITY OF GREENSBURG FIXING THE NUMBER OF OFFICERS AND EMPLOYEES OF ALL DEPARTMENTS OF THE CITY OF GREENSBURG AND THE RATES OF COMPENSATION THEREOF FOR THE YEAR 2016.

The Council of the City of Greensburg ordains as follows:

<u>Section 2.</u> Regular employees shall receive longevity pay based upon total years served with the City. Annual payment shall be in August. Longevity schedule shall be as follows, except as specified otherwise in negotiated contracts:

<u>Longevity Pay – Fulltime:</u> Seventy (\$70.00) dollars for each year of service to be paid after year-two annually in August to a maximum of \$1400.00.

Section 3.

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed.

Section 4.

This ordinance shall become effective the 1st day of January 2016.
