For the record, no one approached the podium to offer any comments or business from the floor.

APPROVAL OF LAST MONTH'S COUNCIL MINUTES

Councilman Finfrock **MOVED** to approve the minutes from last month's Council Meeting, and Councilwoman Lennert **SECONDED**. No discussion. **Unanimously all voted in favor.**

APPROVAL OF MONTHLY BILL LIST

Councilman Finfrock **MOVED** to approve the monthly bill list and pay the bills as the money becomes available, and Councilwoman Lennert **SECONDED**. No discussion. **Councilman Zappone abstained and all others voted to approve the monthly bill list.**

REPORTS OF COUNCIL

Councilwoman Lennert, "Thank you, Mayor. Good evening everyone. Our registration for the 2019 Spring Baseball and Soccer programs will be starting in February. You can contact the office for more information or visit the City's website (www.greensburgpa.org). The recreation office will also start taking reservations for the pavilions at Mt. Odin and Lynch Field on Tuesday, February 5th at 8:00 a.m. The doors to the arena will open at 6:30 a.m. This is done on a first come first serve basis. The cost to rent the Heather Lund and Robert Bell Pavilion at Mt. Odin is \$175 for residents and \$200 for non-residents. The cost to rent the Kaufman and Kallaugher Pavilions at Lynch Field is \$100 for residents and \$125 for non-residents. The Megan Smith Pavilion, at Mt. Odin, will not be available for registration until May. That can be done at the Pro Shop at Mt. Odin. Nevin Arena is in full swing with public skate, skate lessons, and hockey. You can stop down on Sunday, January 20, during public skate from 2 p.m. until 4 p.m. This session will benefit the Humane Society of Westmoreland County. ENACTMENT OF RESOLUTIONS

Resolution No. 1272- A RESOLUTION OF THE CITY OF GREENSBURG, COUNTY OF WESTMORELAND, AND COMMONWEALTH OF PENNSYLVANIA, DESIGNATING VOTING DELEGATES TO REPRESENT THE CITY OF GREENSBURG ON THE WESTMORELAND COUNTY TAX COLLECTION COMMITTEE (WCTCC). Mayor Bell, "The enactment of Resolution No. 1272 appoints Colleen Gain as the Primary Voting Delegate and Kelsye Milliron as the First Alternate Voting Delegate for the year 2019."

Councilman Finfrock **MOVED** to enact Resolution No. 1272, and Councilman Zappone **SECONDED**. No discussion. Roll call vote was taken. **All voted unanimously to enact Resolution No. 1272.**

Resolution No. 1273 – A RESOLUTION OF THE CITY OF GREENSBURG, COUNTY OF WESTMORELAND, AND COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE DESIGNATION OF THE CITY ADMINSTRATOR, KELSYE MILLIRON, AS AN ADDITIONAL SIGNATOR FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM INVOICE FORMS. Mayor Bell, "Due to the time-sensitive nature of the grant program, the enactment of Resolution No. 1273 authorizes the City Administrator as the signator if the Mayor is unavailable."

Councilman Finfrock **MOVED** to enact Resolution No. 1273, and Councilwoman Lennert **SECONDED**. No discussion. Roll call vote was taken. **All voted unanimously to enact Resolution No. 1273.**

INTRODUCTION OF BILL

Bill No. 1-2019 – AN ORDINANCE OF THE CITY OF GREENSBURG, COUNTY OF WESTMORELAND, AND COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 249 ENTITLED 'VEHICLES AND TRAFFIC' OF ORDINANCE NO. 1647 OF THE CODE OF THE CITY OF GREENSBURG. Mayor Bell, "The purpose of the introduction is to amend §249-62, Schedule VI: 'One-Way Streets' changing the direction of travel/limits on Bononi Way from North on Third Street to Pittsburgh Street to North from Second Street to Pittsburgh Street and from South on Third Street to Fourth Street to South from Second Street to Fourth Street. Vehicles turning north onto Bononi Way from Third Street are striking a West Penn Power utility pole causing a safety concern."

ADOPTION OF BILL AS AN ORDINANCE

Bill No. 6-2018 as Ordinance No. 2089 – AN ORDINANCE OF THE CITY OF GREENSBURG, COUNTY OF WESMTORELAND, AND COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 249 ENTITLED 'VEHICLES AND TRAFFIC' OF ORDINANCE NO. 1647 OF THE CODE OF THE CITY OF GREENSBURG. Mayor Bell, "The adoption of Bill No. 6-2018 as Ordinance No. 2089 changes the language in the current Ordinance from 'household and/or dwelling unit' to 'occupied structure' regulating the number of parking permits issued in designated Permit Parking areas."

Councilman Finfrock MOVED to adopt Bill No. 6-2018 as Ordinance No. 2089, and Councilman Zappone SECONDED. No discussion. Roll call vote was taken. All voted unanimously to adopt Bill No. 6-2018 as Ordinance No. 2089.

COUNCIL APPROVAL

- **a.** Reappointment to the Zoning Hearing Board. Mayor Bell, "Council approval reappoints Barry Gaetano to the Board for another three-year term until December 31, 2021."
 - Councilman Zappone **MOVED** to approve the reappointment, and Councilwoman Lennert **SECONDED**. No discussion. **All voted unanimously to approve the reappointment.**
- **b.** Reappointment to the Zoning Hearing Board. Mayor Bell, "Council approval reappoints Justin Calisti to the Board for another three-year term until December 31, 2021."
 - Councilman Mertz **MOVED** to approve the reappointment, and Councilman Zappone **SECONDED**. No discussion. **All voted unanimously to approve the reappointment.**
- c. Reappointment to the Historic and Architectural Review Board (HARB). Mayor Bell, "Council approval reappoints Lynn Armbrust to the Board for another three-year term until January 1, 2022."
 - Councilman Zappone MOVED to approve the reappointment, and Councilwoman Lennert SECONDED. No discussion. All voted unanimously to approve the reappointment.
- **d.** Reappointment to the Historic and Architectural Review Board (HARB). Mayor Bell, "Council approval reappoints Barbara Jones to the HARB for another three-year term until January 1, 2022."
 - Councilman Zappone MOVED to approve the reappointment, and Councilman Finfrock SECONDED. No discussion. All voted unanimously to approve the reappointment.
- e. Reappointment to the Central Westmoreland Council of Governments (CWCOG). Mayor Bell, "Council approval reappoints Councilman Finfrock as the City's Representative to serve on the CWCOG for a one (1) year term until January 2020."
 - Councilman Mertz MOVED to approve the reappointment, and Councilwoman Lennert SECONDED. No discussion. Councilman Finfrock abstained and all others voted to approve the reappointment.
- f. City Solicitor's Base Pay and Hourly Rate. Mayor Bell, "Council approval sets an annual base pay of \$27,330 and an hourly rate of \$150 for City Solicitor Bernard T. McArdle for the year 2019 which is the same as last year."
 - Councilman Finfrock MOVED to approve the base pay and hourly rate, and Councilman Zappone SECONDED. No discussion. All voted unanimously to approve the base pay and hourly rate.
- g. Planning/Zoning and HARB Solicitor's Base Pay and Hourly Rate. Mayor Bell, "Council approval sets the annual base rate at \$4,000 for Louis B. DeRose to serve as the Solicitor for the

Planning Commission and also \$4,000 to serve as the Solicitor for the Zoning Hearing Board and HARB for a total of \$8,000 and an hourly rate of \$125 for the year 2019, which is the same as last year."

Councilman Zappone MOVED to approve the base pay and hourly rate, and Councilman Finfrock SECONDED. No discussion. All voted unanimously to approve the base pay and hourly rate.

h. Appointment to the Library Board. Mayor Bell, "Council approval appoints Janelle Stayt to the Board for a three-year term until December 31, 2021. Janelle has expressed an interest in serving in this capacity and we appreciate her desire to represent the City on the Library Board."

Councilman Finfrock **MOVED** to approve the appointment, and Councilwoman Lennert **SECONDED**. No discussion. **All voted unanimously to approve the appointment.**

i. Reappointment to the Greater Greensburg Sewage Authority. Mayor Bell, "Council approval accepts the reappointment of Guy Hutchinson to the Authority for another five-year term until December 31, 2023 at a salary of \$200 per month."

Councilman Mertz **MOVED** to approve the reappointment, and Councilman Finfrock **SECONDED**. No discussion. **All voted unanimously to approve the reappointment.**

j. Change Order No. 3 for NorthRock Construction, Inc. Mayor Bell, "Council approval accepts the Change Order for an increase of \$600 bringing the total contract price to \$204,029.87 for the Curb and Sidewalk Installation, Contract 1/2018. The Change Order is necessary for additional top soil at Wayne Avenue."

Councilman Zappone MOVED to approve Change Order No. 3, and Councilman Mertz SECONDED. No discussion. All voted unanimously to approve Change Order No. 3.

k. Authorization for the City to Order Road Salt through the Department of General Services (DGS) COSTARS Program for the August 2019-July 2020 season. Mayor Bell, "Council approval authorizes the Fiscal Director, on the City's behalf, to secure the intent to participate online for the order of road salt through the DGS Statewide Contract."

Councilman Mertz MOVED to approve the authorization to order salt through the DGS COSTARS Program, and Councilman Finfrock SECONDED. No discussion. All voted unanimously to approve the authorization to order salt through the DGS COSTARS Program.

I. Hiring of Dispatchers. Mayor Bell, "Council approval accepts the hiring of Christian Koury as a part-time Certified Telecommunicator at a rate of \$16.49 per hour and Gregory Stull as a part-time Dispatcher at a rate of \$14.61 per hour in accordance with rates established by the 2019 Wage Ordinance, effective today."

Councilman Finfrock **MOVED** to approve the hiring, and Councilman Mertz **SECONDED**. No discussion. **All voted unanimously to approve the hiring.**

- m. Hiring of Seasonal Recreation Department Employee. Mayor Bell, "Council approval accepts the hiring of Derrick Halula as a part-time seasonal Recreation Department employee at a rate of \$8.25 per hour, effective today."
 - Councilwoman Lennert **MOVED** to approve the hiring, and Councilman Mertz **SECONDED**. No discussion. **All voted unanimously to approve the hiring.**
- **n.** Change Order No. 4 for Golon, Inc. Mayor Bell, "Council approval accepts the Change Order in the amount of \$3,503.01 for the Renovations to the Veterans' Memorial Swimming Pool. The Change Order is necessary to form, pour and tie rebar of slab at the splash pad utility box and walls."
 - Councilwoman Lennert **MOVED** to approve Change Order No. 4, and Councilman Zappone **SECONDED**. No discussion. **All voted unanimously to approve Change Order No. 4.**
- o. Change Order No. 5 for Golon, Inc. Mayor Bell, "Along with the above Change Order, Council approval accepts this Change Order in the amount of \$1,150.52 to saw cut, excavate, pipe and backfill a seepage pit for the underdrain at the Veterans' Memorial Swimming Pool."
 - Councilwoman Lennert MOVED to approve Change Order No. 5, and Councilman Finfrock SECONDED. No discussion. All voted unanimously to approve Change Order No. 5.
- **p.** Change Order No. 6 for Golon, Inc. Mayor Bell, "Additionally, Council approval accepts Change Order No. 6 in the amount of \$768.32 bringing the total contract price to \$401,590.57. This Change Order is necessary to grind and feather patch the high section of the existing restroom floor."
 - Councilwoman Lennert MOVED to approve Change Order No. 6, and Councilman Zappone SECONDED. No discussion. All voted unanimously to approve Change Order No. 6.
- **q.** Parking Lot Lease between the City of Greensburg and the Keystone Free Will Baptist Church. Mayor Bell, "Council approval accepts the terms of the parking lot lease for the City-owned property located by the current Coal AC Club for a five-year period until December 7, 2023 with an annual lease of \$1,250. This lease replaces the lease agreement approved at the November Council Meeting amending the term from ten years to five years."
 - Councilman Mertz MOVED to approve the lease, and Councilwoman Lennert SECONDED. No discussion. All voted unanimously to approve the lease.
- **r. Business Soft Cost Grant Award.** Mayor Bell, "Council approval awards Ray and Rachel Flowers, owners of Sun Dawg Café, the grant in the amount of \$4,250 for architectural fees related to the expansion of their current business located at 37 North Main Street. This approval is contingent upon obtaining an Occupancy Permit for this location and proof of payment for the fees."
 - Councilman Mertz MOVED to approve the Business Soft Cost Grant Award, and Councilman Zappone SECONDED. No discussion. All voted unanimously to approve the Business Soft Cost Grant Award.
