It is unlawful for a nonresident individual or organization to fraudulently apply for use of City of Greensburg Recreation facilities in the name of a City of Greensburg resident or through the use of a City of Greensburg address. Violators shall be subject to revocation of the permit and permanent loss of user privileges. For the purposes of this fee schedule: rates and age-based rates shall be as set forth in Chapter 151, entitled 'Fees' of Ordinance No. 1646, the Code of the City of Greensburg. Cancellation fees may apply.
