Harry's bar would like to install a projecting sign, giving residents better visibility of the business. Wall mounted projecting sign with a hook & eye connection. The sign will be made of a three-quarter inch PVC material, which will hold up well against the outdoor elements.

Request: Lot Consolidation

Application Brief: Applicant is seeking a lot consolidation of 3 adjacent parcels

(10-04-03-1-032, 10-04-03-1-033 & 10-04-03-4-071)

Suzanne Ward spoke as to why she was seeking the lot consolidation. She purchased a parcel of property from the Land Bank. The other two parcels she had already had possession of. In order to continue with the construction of the indoor/outdoor patio & amphitheater, the lots need to be consolidated. The consolidation would allow for different set-back & lot coverage requirements. The building permits & zoning permits are in process, so this is the final piece to move forward.
