
### CITY OF GREENSBURG SOLICITOR APPLICATION

## This is only for the City of Greensburg, this is not valid for outlying areas that are also considered Greensburg, (i.e. Hempfield Township, South and Southwest Boroughs).

This license is required under Chapter 197, of Ordinance No. 1646, the Code of the City of Greensburg.

Applicants must allow 5 business days after application is received for the purpose of investigating the applicant. The applicant's VALID driver's license must be submitted with this application for issuance of a license.



The Chief of Police shall deny the applicant the license if the applicant has: (1) committed any act consisting of fraud or misrepresentation; (2) been convicted of a felony directly relating to his or her fitness to engage in the occupation of peddler, and including, but not limited to, those felonies involving moral turpitude, fraud or misrepresentation; (3) been charged with a felony and disposition of that charge is still pending; (4) made any false or misleading statements in the application.

Every such person shall carry such license upon his person at all times while engaged in peddling in the City of Greensburg. Persons licensed hereunder shall also carry along with such license photo identification, to be displayed upon request by a prospective customer or law enforcement officer.

PERMIT FEE: \$10.00 a day \$50.00 a week \$200.00 a month < FEES

This fee is to be paid at time of application and is non-refundable even if denied.

(EACH AGENT MUST APPLY IN PERSON AND OBTAIN A PERMIT)

ALL APPLICANTS: must provide a valid state driver's license or proper state identification. They must also bring with them the completed form and a background check completed on Pennsylvania Access To Criminal History website. <a href="https://epatch.state.pa.us/Home.jsp">https://epatch.state.pa.us/Home.jsp</a>

AUTHORIZATION TO RELEASE INFORMATION: must be signed and dated along with the application.

**SOLICITOR HOURS:** No person licensed as a hawker or peddler under this chapter shall engage in hawking or peddling at any time on Sunday or upon any other day of the week at or after dusk.

#### APPLICATION FOR PEDDLER/SOLICITOR LICENSE

This license is required under Chapter 197, of Ordinance No. 1646, the Code of the City of Greensburg. Applicants must allow 5 business days after application is received for the purpose of investigating the applicant. The applicant's driver license must be submitted with this application for issuance of a license. Each individual applicant must complete an application prior to operating with the City of Greensburg. Licenses are effective for ninety days from date of issue. Be advised, complaints of illegal or aggressive sales tactics reported to the City of Greensburg from residents will be immediately forwarded to the Attorney General Consumer Protection Office. If, as a result of a background investigation, the applicant is not found to have committed any of the acts requiring denial as listed below, the Chief of Police shall, upon payment of the prescribed fee, issue the license to the applicant. The Chief of Police shall deny the applicant the license if the applicant has: (1) committed any act consisting of fraud or misrepresentation; (2) been convicted of a felony directly relating to his or her fitness to engage in the occupation of peddler, and including, but not limited to, those felonies involving moral turpitude, fraud or misrepresentation; (3) been charged with a felony and disposition of that charge is still pending; (4) made any false or misleading statements in the application.
