



RETAIL FOOD FACILITY TEMPORARY LICENSE APPLICATION

1. All food vendors must have either plastic tarp material or rubber tiles under all tents and cooking/food prep equipment.
2. The Retail Food Facility Temporary License Fee is \$35.00.
3. On site food inspections may be conducted at random at either setup or during the event. Please make sure that you have both hot and cold water at the required temperatures. Dedicated hand wash sinks (with single use paper towels, soap and signage) are required for all vendors at all times.

Please return the following at least five (5) business days prior to each event:

1. Retail Food Facility Temporary License Application
2. Certificate of Insurance naming the City of Greensburg as additionally insured
3. Copy of Driver's License(s) of truck/trailer operators
4. Copy of current ServSafe/Food Certification Certificate
5. Copy of current health license issued by the PA Dept. of Agriculture and/or Allegheny Health Department
6. Payment of \$35.00 (Please do not mail cash. Your cancelled check will be your receipt.)
